### CHRISTIANE FERAL-SCHUHL PRESIDENT OF NATIONAL FRENCH BAR IS A WOMAN ENGAGED TO THE DEFENCE OF OPPRESSED WOMEN-----

Christiane Ferhal Schull, President of the French National Bar served also as a member of the High Council for Equality between Women and Men (HCEfh) as a qualified person (2013-2015). Her intervention at the Bar Leaders' Discussion of the Opening of the Legal Year of the Law Society of England and Wales, at the Normandy World Peace Forum, had to be noted, regarding the defense of women affected by violence linked to wars and armed conflicts. In addition, the French National Bar mobilized under the leadership of its president, in favor of Nasrin Sotoudeh, the Iranian lawyer was again sentenced in the performance of her duties, to a sentence of 33 years in prison and 148 lashes. As of June 15, 2018, Christiane Ferhal-Schuhl, president of the French National Bar, expressed the concern of the French bar and called for the immediate release of the Iranian lawyer by sending a letter to the Iranian ambassador.-----

On March 12, 2019, faced with the new conviction of Nasrin Sotoudeh, the National Bar Council, with the support of the International Observatory of Lawyers in Danger, which had alerted public opinion in 2018, launched a petition to the attention from President Emmanuel Macron who has collected more than 300,000 signatures. On March 13, Christiane Feral-Schuhl, wrote to the President of the Republic, on behalf of the 68,000 French lawyers, to question him on the situation of our colleague and ask him to take any action useful in his support.-----
